Walmart Checking Accounts

Alternative to Bank Checking Account: Walmart America's largest retailer is getting into the banking business in a big way. Walmart announced it will soon offer low-cost checking in partnership with Green Dot. The new checking account, dubbed GoBank, will be available at Walmart stores by the end of October. According to USA Today: GoBank will charge \$8.95 a month but will waive the fee if customers consent to a monthly direct deposit of \$500. Other fees that are associated with "free" checking accounts at commercial banks — for overdraft, not maintaining a minimum balance or writing bad checks — are waived. Steve Streit, CEO and founder of Green Dot, said in a statement:

Dollars & Cents:

Greetings from the Quartermaster. Update on Canteen business model. As the savings are still being evaluated because some items are paid monthly, some quarterly and some annually the total answer is still unclear. What I can say is we are going to save about \$4500 over the next year in insurance costs. As none of changes generate any additional income we have to wait and see how the savings impact the Post, but right now it looks very favorable.

I am completely open to discussing this with any member. I have and will continue to brief the membership at our monthly meetings. I sincerely hope that these changes result in the benefits we expect. The Post is working towards doing the back roof now that the forward roof is complete. We believe we have enough funds to cover the costs, but anyone who would like to donate a few dollars to help with the finish process it would help. We are very close and are proceeding to get it done, but as with any roof we will not know the true cost until we take the old roof off and evaluate the existing roof structure. I just want to say I am very proud of our Bartenders who are really helping us keep the costs of the canteen and the Post down. You are just great folks. We have run into a couple of bumps recently, the fire inspection of the fire system in the kitchen revealed we need some updates which cost us \$550 and they found one fire extinguisher that needed replacement which cost another \$255. So, we gain we lose... it is a constant battle. We are still looking at trying to find a way to do solar electric for the Post. My guiding rule is that the cost of financing the installation can not exceed the savings we would see as a result of the lower electric bill. We are looking at financing 60 - 80 thousand dollars to have the installation done, it is a big step but can have great benefits for the Post. Thanks, Your friendly Quartermaster Rick Tanner

2014 Elections

The Nation will hold elections on Tuesday November 4th. There are two principles that need to be applied: (1) become informed on the candidates and issues (2) Vote. Many of you sacrificed so this right can be exercised by the public. It does matter who you vote for, but please vote your voice matters and it was a hard won right protected by many Service People.

History of Veterans Day

World War I – known at the time as "The Great War" - officially ended when the Treaty of Versailles was signed on June 28, 1919, in the Palace of Versailles outside the town of Versailles, France. However, fighting ceased seven months earlier when an armistice, or temporary cessation of hostilities, between the Allied nations and Germany went into effect on the eleventh hour of the eleventh day of the eleventh month. For that reason, November 11, 1918, is generally regarded as the end of "the war to end all wars.", In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..."

The original concept for the celebration was for a day observed with parades and public meetings and a brief suspension of business beginning at 11:00 a.m. An Act (52 Stat. 351; 5 U. S. Code, Sec. 87a) approved May 13, 1938, made the 11th of November in each year a legal holiday—a day to be dedicated to the cause of world peace and to be thereafter celebrated and known as "Armistice Day." Armistice Day was primarily a day set aside to honor veterans of World War I, but in 1954, after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83rd Congress, at the urging of the veterans service organizations, amended the Act of 1938 by striking out the word "Armistice"

and inserting in its place the word "Veterans." With the approval of this legislation (Public Law 380) on June 1, 1954, November 11th became a day to honor American veterans of all wars.

Later that same year, on October 8th, President Dwight D. Eisenhower issued the first Veteran's Day Proclamation which stated: "In order to insure proper and widespread observance of this anniversary, all veterans, all veterans' organizations, and the entire citizenry will wish to join hands in the common purpose. Toward this end, I am designating the Administrator of Veterans' Affairs as Chairman of a Veterans Day National Committee, which shall include such other persons as the Chairman may select, and which will coordinate at the national level necessary planning for the observance. I am also requesting the heads of all departments and agencies of the Executive branch of the Government to assist the National Committee in every way possible." The Uniform Holiday Bill (Public Law 90-363 (82 Stat. 250)) was signed on June 28, 1968, and was intended to ensure three-day weekends for Federal employees by celebrating four national holidays on Mondays: Washington's Birthday, Memorial Day, Veterans Day, and Columbus Day. It was thought that these extended weekends would encourage travel, recreational and cultural activities and stimulate greater industrial and commercial production. Many states did not agree with this decision and continued to celebrate the holidays on their original dates.

The first Veterans Day under the new law was observed with much confusion on October 25, 1971. It was quite apparent that the commemoration of this day was a matter of historic and patriotic significance to a great number of our citizens, and so on September 20th, 1975, President Gerald R. Ford signed Public Law 94-97 (89 Stat. 479), which returned the annual observance of Veterans Day to its original date of November 11, beginning in 1978. This action supported the desires of the overwhelming majority of state legislatures, all major veterans service organizations and the American people. Veterans Day continues to be observed on November 11, regardless of what day of the week on which it falls. The restoration of the observance of Veterans Day to November 11 not only preserves the historical significance of the date, but helps focus attention on the important purpose of Veterans Day: A celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good.

Military Discount. Lowe's established the 10% Military Discount to support the men and women who are currently serving our country in the Armed Services and to honor retired service members and recipients of Department of Veterans Affairs (VA) benefits. This 10% discount is also extended to the immediate family of those eligible for the discount. Immediate family is defined as the spouse and children under age 18. To qualify for the Everyday 10% Military Discount, you must:

Be currently serving in, or retired from, a qualifying branch of the Armed Services, or be the immediate family member of someone who is and have a valid military ID Card; or

Be a veteran who receives VA benefits and have a valid Veteran Identification Card (VIC).

Veterans Discount. Lowe's honors all Veterans on three specific holidays: Memorial Day, 4th of July and Veterans Day. During these three holiday weekends, Lowe's will offer a 10% to all veterans who served honorably and who present a valid Form DD214 or other proof of service. The discount is extended to the veteran community on these three holidays only.

COLA Increase Determined

Earlier this year, Congress passed the authorization for Cost of Living Adjustment (COLA) for all Veterans Affairs beneficiaries. What wasn't known at the time was the amount of the increase, which is based off of the Consumer Price Index and determined by the Social Security Administration (SSA). Just this week the SSA announced that COLA will increase by 1.7 percent beginning December 2014

Veteran Legal Clinic SITREP, October 18:. Attorney Craig Candelore, Attorney Howard Thomas (Army Special Forces Sarah Tipton, Military Veteran Advocate and Peer Mentor operated the clinic. We had twelve (12) veterans attended the clinic. Some of these veterans had more than one issue.

1. USMC Vet was seeking assistance in changing an unfavorable (1) DD214 Service Discharge Code and (2) Discharge classification Upgrade. (1) We explained to the Veteran that only the actual military services can change a DD214 discharge code. This issue is different that an discharge upgrade. Like for a discharge upgrade the Veteran needs to obtain his medical and personnel record to see what the Veteran could use in his application and what is in his record that would be used against him. The Veteran needs to address his request to the Commandant of the Marine Corps (2) Because Veteran was recently discharge he could apply for a discharge upgrade from either Service Boards that have the power to upgrade. Veteran had a compelling case since he had served well and honorably for 20 years but due to two DUIs, after returning from overseas deployment, was "cashiered" from the Marine Corps. The Veteran received a General Discharge under Honorable Conditions but feels he deserves an Honorable Discharge. Veteran believes that because he was not diagnosed with PTSD upon his return from deployment the service, he was not treated properly.

2. USN Vet was seeking assistance in changing an unfavorable (1) DD214 Service Discharge Code and (2) Discharge classification Upgrade. (1) We explained to the Veteran that only the actual military services can change a DD214 discharge code. This issue is different that an discharge upgrade. Like for a discharge upgrade the Veteran needs to obtain his medical and personnel record to see what the Veteran could use in his application and what is in his record that would be used against him. The Veteran needs to address his request to the Secretary of the Navy (2) Veteran had a conflict with his crew, the command booted him out. 3. USN Vet was seeking assistance with three (3) issues: (1) Lawsuit against a SD police officer for assault (2) Lawsuit against a naval base gate guard (3) Family law matter. Veteran claims he was assaulted by a SD police office without cause which caused him physical injuries. He claims he was with two witness. Veteran was referred to an attorney who specialized in alleged police abuse to see if the case has merits. (2) Regarding the assault and battery by a DOD gate guard the Veteran was referred to Personal Injury Attorneys who specialized in the Federal Tort claim Act. (3) Mother of his child was in Seattle and moved to Idaho without notifying him. His case is in the Department of Child Support Service system up in Seattle. Veteran was told to have his case transferred from Seattle to San Diego since Mom was no longer in Seattle. Normally, like all Civil Cases, DCSS cases are prosecuted where the "Defendant" lives. Once the case is moved down to San Diego he could file a motion for custody and visitation.

4. USN Vet was seeking assistance in changing an unfavorable DD214 Service Discharge Code. We explained to the Veteran that only the actual military services can change a DD214 discharge code. This issue is different that an discharge upgrade. Like for a discharge upgrade the Veteran needs to obtain his medical and personnel record to see what the Veteran could use in his application and what is in his record that would be used against him. The Veteran needs to address his request to the Secretary of the Navy. Veteran had a compelling case as he was honorably discharged after serving 7 $\frac{1}{2}$ years without a blemish but the Navy for some reason gave him a R-4 reentry code. It appears this was simply human error on the part of the discharge clerk typing up the DD214.

5. USN Vet was seeking assistance in how to handle the Immigration Application for his Wife who was in the US without authorization. Veteran and Wife have a 3 year old child who was born in the US. Normally a person cannot apply for legal status from an illegal status. However given the hardship, we believe Wife could receive a waiver to apply for her green card while living with her husband and child in the US. Veteran was referred to several immigration attorneys.

6. USN Veteran was seeking assistance on drafting a Will. He has an old will that leaves assets to his Ex-Wife and give his Ex-Wife a power of attorney. Vet needs to immediate revoke his old will and power of attorney and update his will and power of attorney.

7. USN Vet was seeking assistance in changing an unfavorable (1) DD214 Service Discharge Code and (2) Discharge classification Upgrade. (1) We explained to the Veteran that only the actual military services can change a DD214 discharge code. This issue is different that an discharge upgrade. Like for a discharge upgrade the Veteran needs to obtain his medical and personnel record to see what the Veteran could use in his application and what is in his record that would be used against him. The Veteran needs to address his request to the Secretary of the Navy (2) Veteran was within the 15 years statute of limitations to apply for a discharge upgrade. The Veteran received an Other Than Honorable. However Veteran had untreated PTSD and may use this to request a tolling of the 15 year statute of limitation. Explained that overcoming the 15 statute of limitation was an uphill battle.

8. USN Vet is seeking information on how to file a VA disability claim. The veteran was being treated at the VA for ongoing medical problems. The Veteran had not yet filed for his VA disability claim. He was referred to Marilyn Maxwell the VFW VSO. We provided the Veteran with the contact number and drew a strip map on how to physical locate Marilyn at the Mission Valley VA building.

9. USN Vet was seeking assistance with current Family Law matter involving divorce, paternity, domestic violence, child custody, and child support. We reviewed all her paperwork and explained where her case was in the legal system and what was her next step. Veteran is simply overwhelmed. Referred the Veteran to several family law attorneys.

10. USN Vet seeking assistance with a Discharge Upgrade of a Other Than Honorable (OTH). The Veteran was discharged from the Navy in the early 1980s. We explained that he was past the 15 year statute of limitation for filing for a discharge upgrade. His best chance is to request a tolling of the SOL due to PTSD. We explained that he had an uphill battle. First step was to obtain all his medical and personnel records.

11 USMC Vet was seeking advice on how to apply for an increase in VA disability compensation. His service connected medical injuries had gone from bad to worse, namely his leg and knee and the Veteran wanted an increase in disability rating and compensation. He was referred to Marilyn Maxwell the VFW VSO. We provided the Veteran with the contact number and drew a strip map on how to physical locate Marilyn at the Mission Valley VA building.

12. USMC Vet was asking advice on how to proceed after being sued for Trademark Infringement lawsuit. Plaintiff, a big Los Angeles restaurant chain, was suing Defendant Veteran for name infringement. Veteran operates a "mom and pop" fast food on wheels. Plaintiff claims the Defendant's business name is close to the Plaintiff's business name. It is not. The lawsuit seems totally without merit. HRT will help the Veteran draft a letter requesting a dismissal based on "no confusion of names in the market place" defense. This case appears to be a case of oppression and malicious prosecution


