DOD Launches Website on New Prescrip-

tion Drug Policy: Earlier this month, the VFW reported on a new TRICARE prescription drug policy that will require certain beneficiaries to refill select maintenance medications through home delivery or at military treatment facilities. This week, TRICARE published a summary of the changes on its website, including which beneficiaries will be affected, which medications will fall under the new rules, how to request waivers if necessary, and contact information for additional questions. Active duty military personnel are exempt from the new policy. The change will take place on October 1, 2015, and DOD will begin sending letters with additional information to beneficiaries on September 1. Dollars & Cents:



Greetings from the Quartermaster. The solar saga continues. The Post is still having difficultly in obtaining financing for the Solar Project (\$150,000). Cdr Dave and I are investigating a Power Purchase Agreement (PPA) which seems very advantageous to the Post. Perk Electric, would put the solar system on the Post and we agree to purchase our Power from them at a reduced rate (15cents vs 28cents from SDGE). The Post is allowed to buy

the system at specific times during the 20 year life of the PPA. At the 6 year point the Post can purchase the system for \$60,000 which is about 40 percent of the actual costs. We have to pay for all power generated by the solar system and SDGE for power the Post uses when solar is not producing power. My analysis of this PPA shows that we will save money on the cost of our electricity during the 6 year period. The Post would save that money towards purchase. The Post will have to raise the \$60,000 purchase price during the 6 year period through donations, fundraisers, etc. The Post would borrow the difference between what we raise and the \$60,000 as that is the most advantageous to the Post. Affordable Care Act (ACA): Recently Under the Affordable Care Act (ACA), all Americans including all military members (active duty, retired, Selected Reserve, or Retired Reserve) and their eligible family members must have health care coverage that meets a minimum standard called minimum essential coverage or pay a fee. Your TRICARE coverage meets the minimum essential coverage requirement under the ACA. "The term "active duty" means full-time duty in the active service of a uniformed service for more than 30 consecutive days". Beginning in January 2016, DFAS will be providing IRS Form 1095-C to all U.S. military members, and IRS Form 1095-B to all Retirees, Annuitants, former spouses and all other individuals having TRICARE coverage during all or any portion of tax year 2015. An IRS Form 1095 documents you (and your family members, if applicable) have the minimum essential coverage. More information will be forthcoming about the delivery method of these forms. These forms will document the information that DFAS will provide to the IRS on yourself and your authorized family members. The forms will be required to be reported with your 2015 federal tax return. DFAS will provide you with IRS Form 1095 series forms no later than Jan. 31, 2016 You can find more information about the impact of the Affordable Care Act on your federal income tax at: http:// www.irs.gov/Affordable-Care-Act, or http://www.dfas.mil/taxes/aca.html.

Here is the HRT Veteran Legal Clinic SITREP for today Saturday, August 15, 2015 that took place at the VFW Post 3787 from 9:00 AM to 1:00 PM. Attorney Craig Candelore (USA), Attorney Dale Santee (US Air Force JAG), Attorney Paul Abels (US National Guard), and Sarah Tipton (Military Veteran Advocate and Peer Mentor) operated the clinic.

1. Need: Many veterans who come to our clinic are in a state of transition due to unresolved legal issues they had before they left the service. These unresolved issues is holding them back from fully integrating back into society. Many of the cases we receive have been unresolved for years which prevents the veteran from obtaining needed benefits, employment, or housing. Many of the unresolved issues take multiple hours to resolve and are impossible to resolve over night mainly because the legal system works on its own time and its own pace. Some veterans due to PTSD or other health issues avoid handling their legal issues. This causes their situation to grow worse and without our assistance and guidance, the veteran is left dead in the water without being able to improve or make a better life for themselves.(1). US Navy Vet seeking a discharge upgrade from OTH to Honorable. He had his personnel file and his medical file. Explained what form to use and where to send in the packet and how to organize the packet. He was discharged recently and is within the 15 Statute of Limitations. Was discharged due to marijuana and alcohol issues due to marital problems. (2). US Army Vet seeking a discharge upgrade from OTH to Honorable. He did not have his personnel file and his medical file. Explained how to obtain those records. Explained what form to use and where to send in the packet and how to organize the packet. He was discharged recently and is within the 15 Statute of Limitations. Passed a drug test but was still discharged do to the testimony of witness in his unit. The process was unfair because the vet was never given the opportunity present his own defense. (3). US Navy Vet seeking a discharge upgrade from OTH to Honorable. He did not have his personnel file and his medical file. Explained how to obtain those records. Explained what form to use and where to send in the packet and how to organize the packet. He was discharged recently and is within the 15 Statute of Limitations. He failed a drug test voluntarily to get out of the Navy to take care of his suicidal father. Very unique set of facts. (4) US Navy Vet seeking a discharge upgrade from OTH to General. He did not have his personnel file and his medical file. Explained how to obtain those records. Explained what form to use and where to send in the packet and how to organize the packet. He was discharged in 1996 and is outside the 15 Statute of Limitations for the DRB (Discharge Review Board). He is outside the three (3) year Statute of Limitations for the Board of Corrections for Military Records (BCMR). However the BCMR sometimes will accept late applications with good reason. He was discharged for spousal abuse, failure to obey orders and Use of a stolen credit card. Most of the reasons can be for the discharge can be explained away. We explained that we would use a tolling theory to explain why he did not file within the three (3) year SOL in front of the BCMR namely, father suicide sent him into a tail spin from which he only recently recovered. (5) US Navy Vet as fired

from a data processing VA employment (Employment discharge) because he could not process the material fast enough. He feels the firing was improper because he had notified the VA that he had a learning disability and should qualify for American Disability Act consideration. Referred him to EDD and ADA reps in San Diego. (6) USA vet come in for advice on family law and motorcycle accident. needs a divorce from a Wife with whom he has been separated since 2009. He has had custody of his 4 year old child. He is afraid Mother/Wife will seek to kidnap the daughter since there are no court orders. Mother/Wife has not permanent address so it will be hard to serve her. Explained that he may need to serve by publication or subservice to a generally know address. The service of process is the complication. Judges do not give orders for service by publication without the party showing due diligence on locating the other party. Veteran was involved in a motor cycle accident. Explained how to submit a demand letter to opposing party's insurance carrier. (7) US Navy Vet involved in a protracted custody battle. Father is stationed at 32nd Street. Mother without court order moved to Los Angeles County. Mother is frustrating visitation. Explained the process of filing for a child custody modification in court. Explained the child custody modification process and what he should seek to include summer vacation and SKYPE contact. (8) US Marine Corps seeks Expungment for Felony conviction in 2009. He was represented by a Public Defender. Explained that he can do back to the PD and ask for his felony conviction to be expunged. The PD will know the local rules and the local judge proclivity. Explained that normally judges entertain a felony expungment after 10 years of conviction. He only has 7 years' post conviction. However he has completed probation and paid all his fines. He also had dozens of letter of recommendation. He says conviction is hurting him obtain a job. Asked him to inquire if he qualifies for Prop 47 reduction. (9) US Marine Corps seeks advice on how to deal with existing debts. Owes approximately \$15K in back child support, Juvenile Court support order, and Franchise Tax Board taxes. Explained that the back child support was due to mother receiving welfare he may make an offer and compromise to the county. Same with the Juvenile Court order. Explained that he should approach the Franchise Tax Board and negotiate a payment plan. (10) US Marine Corps seeks advice on how to address VA Pension overpayment withholding. Vet feels that the VA should not be taking any money for any alleged pension overpayment. Veteran believes that here is a case of mistaken identity. The VA is still taking away VA Pension due to mistaken identity. Advice vet to obtain the "C" file to understand the VA reasoning and accounting. (11) US Army, seeks a Discharge Upgrade and Disability Compensation Upgrade. Vet came in without any documents. Told the Veteran need to obtain his "C" file and explained to him how to obtain the "C" file. Explained the process for both the Discharge Upgrade and the Disability Compensation Upgrade. Clinic history: The Veteran Legal Clinic has been operating since early 2009. The Veteran Legal Clinic has never missed, cancelled, or postponed its scheduled meetings since 2009. Space-A Eligibility Eases for Families of

Deployed: More military families are now authorized to fly Space-Available aboard military transport aircraft thanks to a VFW-supported recommendation made by the Military Compensation and Retirement Modernization Commission. Previously, a service member had to have been deployed 120 days or longer in order for families to fly Space-A unaccompanied. Now it's 30 days. Dependents must still have a letter from their sponsor's commander to verify the deployment. Your resume was shortlisted for an online interview with one of the HR Manager Mr Max Tyler and he would like to conduct an on-line interview with you as soon as possible to discuss more about the pay scale, benefits and Job Position that you are yet to occupy.

Set Up a Screen name with yahoomail.com, or a Google Hangout to your device (PC or Phone) if you don't have one and instantly add up and message him on Yahoo Instant Messenger, His ID is: max.tyler@yahoo.com to your buddy list and for Google Hangout here is his ID maxtyler07@gmail.com. Add Him up to commence your Briefings and Interview he will be on-line waiting for you.

There is no way to police this as it is individual people creating fake accounts, and then blast emailing people in the event someone bites. BEWARE


